- ✓ If New Venture, experience of the owner for the past 2 years in a relevant industry (this should be outlined within the New Venture profile)
- ✓ Improvement plans where required due to CAB scores
- ✓ Prior Premiums and historical unit count for current and prior 3 years (if applicable)
- ✓ Acord applications signed (to bind)
